

Registration for Portugal Photography Tour April 24 thru May 7, 2010

THE COST

The cost is \$4650 (land cost). The cost is based on hotel double occupancy. A \$500 single supplement is applied to those wishing a private room. A deposit of 50% of the total cost (check or money order sent and paid to: Bob Spencer Photography, 390 East 12th Street, #3, Durango, CO 81301, USA) for each person is due upon registration to hold a place for you in the tour. The balance is due no later than 90 days prior to the beginning of the tour. This price includes all hotels and all transportation throughout the tour. Included are all breakfasts, four lunches and five dinners. Also included are entrances fees to museums and sites that we enter as a group. And all photographic instruction is included in the tour. You are responsible for your own transportation to and from Portugal. Items such as drinks souvenirs, laundry, telephone, tipping etc are not included.

CANCELLATION POLICY

- Up to 60 days prior to departure: You receive all money deposited.
- 60-31 days prior to departure: You receive all money deposited minus a \$150 administrative fee.
- 30 days prior to departure through conclusion of the tour: The full cost is forfeited unless the space can be filled within 30 days of the beginning of the tour.
- In the unlikelyness that the tour is cancelled by Bob Spencer Photography all money deposited will be returned by check.
